

ADDENDUM TO POWER SPORTS RENTAL AGREEMENT

You acknowledge that You are **REQUIRED** to have in force comprehensive, collision and vehicle liability covering You, Us and the rented vehicle as a condition of rental. Without insurance purchased from **MBA Insurance** herein there would be no comprehensive and collision protection for You for damage to the Vehicle and no Vehicle Liability insurance for third party claims.

INSURANCE THROUGH MBA

You acknowledge that this transaction is non-refundable and you agree to comply with the terms and conditions for this transaction as follows:

- A \$3 minimum service fee will be added to all initial online purchase transactions.
- Any changes or cancellations of this transaction are subject to a \$40.00 service fee.
- The insurance is non-transferable and only covers Authorized Drivers as shown on the rental agreement.
- No coverage is bound until this application and payment is received by MBA and evidence of insurance has been delivered to the rental operator.

*These limits can be raised by purchasing Supplemental Liability Insurance.

OPTIONAL SLI COVERAGE – (Scooter, ATV, and Golf Cart Rentals Not Eligible)

For an additional \$5.95 per day you may elect to purchase Supplemental Liability Insurance (SLI) which raises your liability coverage from the state minimum limits to up to \$300,000 bodily injury liability and up to \$50,000 property damage liability for the coverage dates indicated above. By selecting SLI coverage you authorize MBA to charge your card for an additional \$5.95/day.
