

OFFICIAL RULES

2026 Flower and Patio Show Prize Sweepstakes

1. Sponsor

This sweepstakes is sponsored by Start To Finish, Inc., located in Whitestown, Indiana.

2. Eligibility

Open only to legal residents of Central Indiana who are 18 years of age or older at the time of entry. Void outside the eligible area and where prohibited by law. 3. Sweepstakes Period

5. Prize

One (1) winner will receive a \$2,500 outdoor lighting package, consisting of:

- One (1) transformer

*Installation is not included. If the winner does not elect to have Start To Finish perform the installation, the winner is responsible for picking up the prize from the Sponsor's shop. Approximate Retail Value (ARV): \$2,500.

6. Winner Selection and Odds

One (1) winner will be selected in a random drawing from all eligible entries received. Odds of winning depend on the number of eligible entries received.

The selected winner will be notified by phone or email within five (5) business days of the drawing.
