

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to [www.sabattuscapital.com](http://www.sabattuscapital.com) and Sabattus Capital, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Sabattus Capital, LLC include [www.sabattuscapital.com](http://www.sabattuscapital.com) and Sabattus Capital. The Sabattus Capital website is a Financial Services site. By using the Sabattus Capital website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Sabattus Capital may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address

  - Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
