### 1. Purpose

Party A has developed a proprietary tool/concept known as the “**Cycle Clock**” (representing Trauma, Emotions, Triggers, Anger, and Behavior). This Agreement sets forth the terms under which Party A will provide, license, or collaborate with Party B in using the Cycle Clock for **[educational, training, therapeutic, or business purposes]**.

### 2. Scope of Services

Party A agrees to provide:

- Access to the Cycle Clock concept/materials.
- Training, presentations, or workshops on the model.
- Supporting materials (manuals, visuals, or digital content).
- Ongoing consultation (if applicable).

Party B agrees to:

- Use the Cycle Clock only for authorized purposes.
- Provide credit to Party A when the concept is displayed or used publicly.
