

DRIVING DIRECTIONS

From I-270 in NW St. Louis County, take Exit 22A/B for MO 370 West toward St. Charles. After crossing the Missouri River, take the first exit for Hwy 94 East. That's a cloverleaf. Turn left at Hwy 94. At the second stoplight, turn left onto Fox Hill Road for a couple miles. Turn left at Tamarack Drive, then immediately turn right onto Kister Drive. Drive straight into the park and park in the lot.

From the west, take I-70 Exit 224 for Hwy 370 East, then take Exit 5 for Elm Street. Turn right on Elm, then left on Elk Point Industrial Drive. Turn right on Mueller Road, left on Boschertown Road, turn right onto Fox Hill Road, go up the hill, turn right on Tamarack Drive and then make an immediate right onto Kister Drive which goes directly into the park.

New Town is a uniquely designed, very walkable housing project. It has 90 acres of retention ponds that connect 3,500 units and allow water sports close to one's front door. Small neighborhood squares and courts weave throughout. Some neighborhoods are reminiscent of beach homes, some of Brooklyn brownstones, but all are unique. Nice parks, too!

The 10K follows Boschert Creek before entering New Town. The 5K is a loop starting from a side street. Drive there after registering.

START LOCATION: Fox Hill Park parking lot (GPS: 38.81951, -90.49118), 3400 Kister Drive, St. Charles, MO. Park and walk to the gazebo.

PARKING: Free parking on the lot.

TIME: Register 9-11 am. This event will take place regardless of weather.

ACCOMMODATIONS: Restrooms are available near the gazebo. There are also restrooms available in New Town Center and in the New Town Post Office.

DISTANCE: 5k and 10k routes have detailed directions and maps. The routes are doable for strollers or wheelchairs.

REGISTRATION: Fee is \$4 for each walker. All events are open to everyone. Club membership is not necessary.

REFRESHMENTS: We'll have water available at the Start and Finish for everyone. Please consider patronizing the shops in New Town.

PETS: Leashed pets are allowed on the walk but not inside buildings. Please clean up after your pet and bring fresh water for it. Dog walking is popular in New Town.

PROCEDURE: To register, get a Start card and fill it out and turn it in. \$4/walker.
