## Broker-Carrier Agreement

This Agreement ("Agreement") is made and entered into on [Date] by and between Quantum Dispatching Company, LLC ("BROKER"), a licensed freight broker (MC# pending), and [CARRIER NAME], with its principal place of business at [CARRIER ADDRESS] ("CARRIER").

### 1. CARRIER RESPONSIBILITIES

CARRIER agrees to safely and legally transport freight arranged by BROKER in accordance with FMCSA regulations. CARRIER shall maintain all required authority, insurance, and driver qualifications.

### 2. BROKER RESPONSIBILITIES

BROKER agrees to tender loads to CARRIER for transport, provide rate confirmations, and assist in issue resolution. BROKER will verify insurance and authority compliance.

### 3. RATES AND FEES

CARRIER will be paid as per agreed rate confirmations. A 10% brokerage fee is standard unless otherwise specified on a load-by-load basis.

### 4. PAYMENT TERMS

BROKER shall remit payment within [\_\_\_\_\_] days after receiving proof of delivery and any required documents. Direct deposit is available upon request.

## 5. CLAIMS AND LIABILITY

CARRIER is responsible for any freight damage, loss, or delay while in transit. BROKER will facilitate the claim process but holds no direct liability.

## 6. TERM AND TERMINATION

This Agreement is effective until terminated by either party with 30 days written notice.

## 7. DOCUMENTATION REQUIRED

CARRIER must provide the following:

- Signed Broker-Carrier Agreement
- MC Operating Authority
- W-9 Form
- Certificate of Insurance
- Equipment List and Operating Lanes

## 8. GOVERNING LAW

This Agreement is governed by the laws of the Commonwealth of Virginia.
